Summary



23 incidents occurred in December in the Santa Fe BID.

- 78.3% of incidents in December are property crimes (18 incidents).
- There is an overall increase of 130.0% for all incident types when comparing December to November 2022 (10 in November, and 23 in December).
- There were 2 aggravated assaults and 1 simple assault in December.

85 police calls for service were received during December in this area.

- 74 or 87.1% were citizen-initiated.
- 11 calls or 12.9% were officer-initiated.
- 23.5% of calls were for trespass/unwanted persons (20 calls) and 9.4% were alarm calls (8 calls).

Executive Director Updates

Streetscape Project | Parklet - Wesley Dismore

- RFP out on the field and consulting team preparing the proposal and they are due Feb 6 and two weeks are given to review proposals and get a consulting team on board to start developing the process.



David Brehm - A few questions and concerns and have a start-up meeting and get some public feedback and see what the successes were and re-state the intended goals etc. Going on what was done three years ago may be outdated, maybe having a large public involvement. So that it isn't too late and then no one likes it, so that we don't encounter resistance. Maybe re-visit and understand what the design is about and the goals as it is a concern that this is a substantial public design.

The purpose of the RFP is to hire a team so that they do public engagement 100% and they are brought on as part of the team and nail down the schedule. The tasks listed on RFP are not intended to be completed in that schedule. It is reasonable to say that they can adjust tasks and the consultants understand the need to be proactive and reactive and the need to engage everyone. There are components that are not in order, the bidding proposal will be the one providing how they will complete the process.

There is usually a linear process that is followed that moves from point A to point B etc. But one of the reasons it is being left open in how the process is completed is that it is being put on the consultants so that they can move forward depending on the cyclical process being led by the consultants. As every piece of the project informs every other piece. A large budget and large design process thus leaving it clear and open to keep working forward. Andrea reminded Wesly to include a bullet for a lighting plan for Santa Fe. The consultant teams that received the RFP have already found that the lighting needed was not there and they are proposing additional needs or intent and character of the corridor. The teams propose to impress and that adds the opportunity to add to the scope.

After much discussion and defined information regarding the project and the understanding of how the selection process of consulting team will be selected and that all issues will be incorporated the team decided on the following:

ASKS

- 1. Ask if we can have BID representation or one non-voting member advisor to represent BID
- 2. Ask if once the RFP is awarded and is the basic legal contract if we can incorporate the opportunity to allow for amendments to be done.

All in all, if we as the BID draft something that feels good and sends it over to Wesly so that once the project team has been selected they receive this incorporated into the scope of work. The selection will happen in late February or early March.

Santa Fe BID Renewal Requirement

Reminder of the Santa Fe BID's 10-year renewal requirement. The Creation Ordinance for the BID contains a reference to the petition and initial operating plan for the renewal requirement, and the initial operating plan has the renewal language. By Michael Kerringan's calculation, the ordinance approval to renew the Santa Fe BID must be completed by 8/18/2024.
